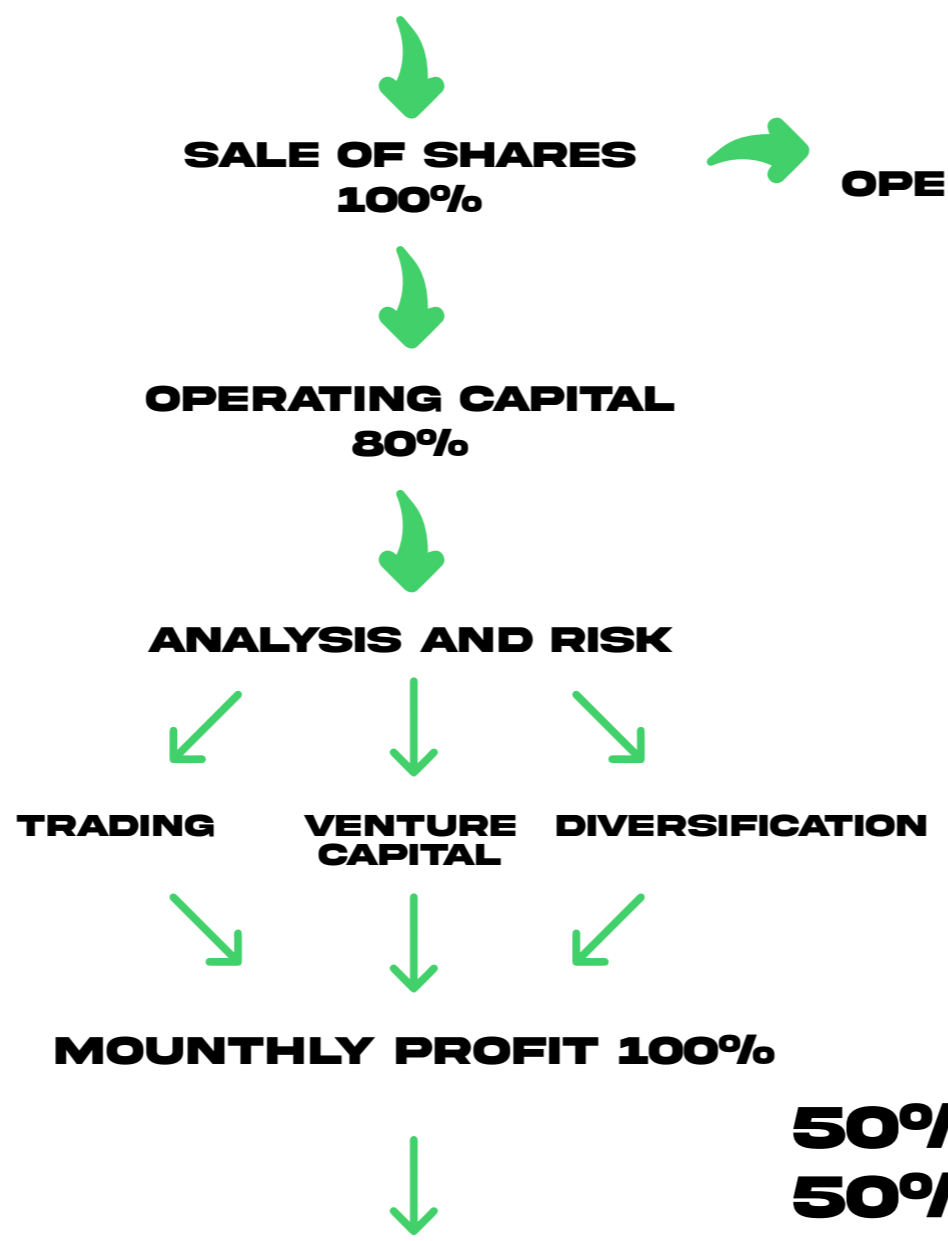

QUARTERLY POOL



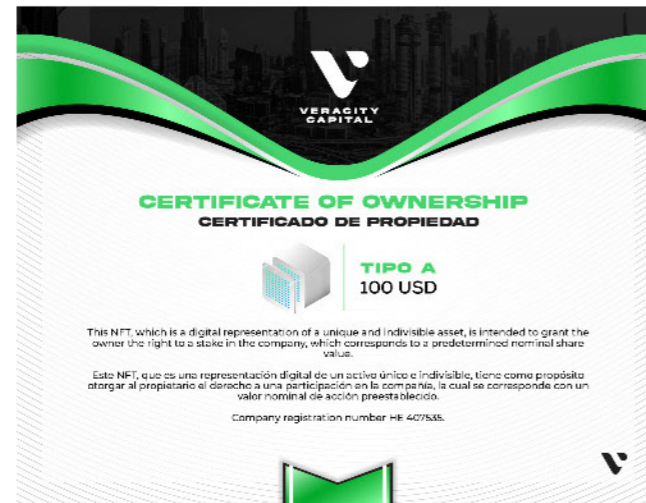

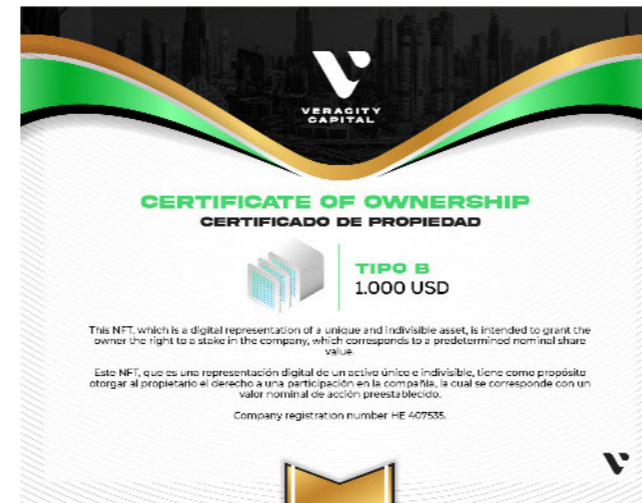

FREQUENTLY ASKED QUESTIONS

WHERE IS THE COMPANY LEGALIZED?

We are located in Cyprus, a country that has expert providers of legal and financial services, facilitating and streamlining international business transactions.

WHAT ARE THE AVERAGE RETURNS OFFERED BY VERACITY?

We offer a grounded performance based on our experience, with an estimated range of 60% to 240% annually. However, in equity markets, fixed returns cannot be guaranteed.

WHAT IS THE BIGGEST RISK VERACITY IS EXPOSED TO?

We operate with the utmost caution and without risking the capital. We are aware that this is a long-term business, and we ensure that the account is not exposed to any risk of liquidation under any circumstances.

CAN I PURCHASE SHARES IN AMOUNTS SMALLER THAN EXISTING SHARES?

Yes, we offer 3 ownership certificates (shares) A - B - C, allowing you to purchase multiple shares individually. For example, if you buy shares worth 300 USD, you will acquire 3 "A" type shares.

WHAT IS THE MINIMUM WITHDRAWAL AMOUNT?

The minimum withdrawal amount is \$30 USD.

WHAT ARE THE TIMEFRAMES AND FEES FOR WITHDRAWALS?

Direct commissions for the sale of shares are available once the payment has been made and have a withdrawal fee of 5%. The liability is reflected in the back office 24 hours after the daily operations close. The accumulated amount can be requested within the first two business days of the month and **HAS A WITHDRAWAL FEE OF \$2 USD.**

AM I OBLIGATED TO MAINTAIN MY INVESTMENT FOR A SPECIFIC PERIOD?

No, you can request VC to repurchase your shares at any time. Please note that the percentage paid in ascending commissions will be deducted from the total, and it will be distributed proportionally over 12 months.

Example: If you buy shares for 1,000 USD, of which 200 USD are paid as commissions and 800 USD go to the trading fund, the 200 USD will be divided over 12 months ($200 / 12 = 16.66$). If you request the repurchase of your shares, the number of months you have stayed in the pool is multiplied. Continuing with the example, if you have been in the pool for 6 months, it would be $16.66 \times 6 = 100$ USD. You will receive a total of 900 USD for your shares, plus the earnings generated during those months. After one year, the penalty is waived, and you can receive 100% of the capital invested in your shares, plus the generated profit.

WHAT HAPPENS IF IN A GIVEN MONTH THE GENERATED PROFIT IS INSUFFICIENT TO PAY THE CAREER PLAN BONUS?

This is unlikely to happen. Each month, once the Generational Bonus has been paid, any surplus from the Compensation Plan is allocated to the Career Plan, creating a reserve fund for future payments. If, however, in any month, the payment of the Career Plan exceeds this reserve fund, the payment for each rank will be proportionally reduced based on the excess amount, ensuring the long-term sustainability of the system.
